

# TORTIYAHS! WESTOCK REQUEST SWEEPSTAKES

## OFFICIAL RULES

- 1. SPONSOR:** TORTIYAHS! WESTOCK REQUEST SWEEPSTAKES (“Sweepstakes”) is sponsored by Utz Quality Foods, LLC and WeStock (“Sponsors”). The entry information provided will only be used in the event that entrant is selected as a sweepstakes winner or if the entrant has indicated he/she would like to receive additional information from Sponsors. Sponsors will not provide any entry information to any third-party.
- 2. ELIGIBILITY:** NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older as of date of entry. The Sweepstakes is void where prohibited. Employees of Utz Quality Foods, LLC, TORTIYAHS! their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies (collectively, “Released Parties”), and their immediate and extended family members (including but not limited to spouses, domestic partners, parents, children, and siblings) and household members of each (whether related or not) are not eligible to participate in or win a prize in the Promotion. All federal, state and local laws and regulations apply. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. Each Entry:
  - Must include all elements: Must request at least one TORTIYAHS! Items
  - Must not contain material that is unlawful, in violation of, or contrary to the laws or regulations in any jurisdiction where Entry is created.
